State of affairs

Preparatory phase:

November 2012 – October 2015, extended to April 2016

3 informal meetings with national representatives

October 2015, Schiphol (NL, PL, ES, BE, FR, RO, UK) February 2016, Berlin (PL, ES, FR, BE, NL, SK) January 2017, Berlin (DE, FR, ES, PL, PT, NL, BE, SK, IT, GR)

After these 3 meetings:

Majority of countries in favour of ERIC Coordinator of preparatory phase no longer involved

Define what is needed to establish MIRRI as ERIC:

- Governance during Construction Phase
- Procedure to select the host country of statutory seat
- Gap analysis: availability of documents needed to set up MIRRI-ERIC

ASSEMBLY OF PROSPECTIVE MEMBERS

- Composition:
 - Prospective MIRRI Member States (i.e. countries that have signed the MoU)
 - At least 1, but up to 3, representatives per prospective MIRRI Member State ("Ministry level")
 - Each prospective MIRRI Member State has one vote
 - Observers (i.e. countries evaluating the possibility to join MIRRI-ERIC) are allowed (no voting rights)
 - Chair and Vice-Chair to be elected by the Assembly of prospective Members (1)



ASSEMBLY OF PROSPECTIVE MEMBERS

- Tasks:
 - Negotiate Statutes, including funding model and national contributions (membership fee)
 - Prepare the minimal requirements / call for tender for the statutory seat and select the host country for the statutory seat
 - Define the mandate of the Interim National Coordinators Forum
 - Approve the Chair and Vice-Chair of the Interim National Coordinators Forum (1)
 - Approve the scientific and technical description of MIRRI-ERIC
 - Attract new prospective MIRRI Members
 - Elaborate the MIRRI business plan



ASSEMBLY OF PROSPECTIVE MEMBERS

- Timing:
 - Start in Month 1 (September 2017)
 - First meeting beginning Month 2 (October 2017)
 - End when MIRRI-ERIC is established (when official Assembly of Members takes over)



INTERIM NATIONAL COORDINATORS FORUM

- Composition:
 - At least 1, but up to 3, representatives of the BRC community per prospective MIRRI Member State (representative(s) to be designated by the prospective MIRRI Member State)
 - Each prospective MIRRI Member State has one vote
 - Observers are allowed (no voting rights)
 - Chair and Vice-Chair to be elected by Interim National Coordinators Forum (to be approved by the Assembly of prospective Members) (1)



INTERIM NATIONAL COORDINATORS FORUM

- Tasks:
 - Act upon the mandate given by the Assembly of prospective Members

During the meeting the following tasks were already foreseen for the Interim National Coordinators Forum (to be included in mandate):

- Prepare scientific and technical description of MIRRI-ERIC
- Prepare the implementation of MIRRI on scientific and technical level (establish work programme for 2018-2019)
- Coordinate the MIRRI activities of the local BRC community



INTERIM NATIONAL COORDINATORS FORUM

- Timing:
 - Start in Month 2 (October 2017)
 - End when MIRRI-ERIC is established



INTERIM SECRETARIAT

Tasks

- Support the operation of the Assembly of prospective Members
- Support the operation of the Interim National Coordinators Forum
- Communicate with the MIRRI preparatory phase partners and associated partners
- Keep track of all MIRRI activities and documents



INTERIM SECRETARIAT

Timing:

Start in October 2017 End when statutory seat is selected (or at least to be rediscussed at that moment)

Belspo offers administrative, logistic and organisational support for the Interim Secretariat.

Italy and France will check whether they can offer support for the Interim Secretariat.

Website is at present maintained at DSMZ, via CORBEL funding



Host country of statutory seat

- Open bidding, call to all EU Member States
- Call secretariat (Work group of the Assembly) to prepare call
- Portugal has expressed his interest
- Spain offers in kind contribution for ICT (based on Lifewatch facilities)



Gap analysis: availability of documents needed to set up MIRRI-ERIC

- 1. A request to the Commission to set up the ERIC
 - Model request is available
 - Request must be signed by all Members (step 2)
- 2. Proposed statutes of the ERIC
 - Proposed statutes in MIRRI D3.2.
 - Can be used as basis for discussion (revision is needed)
- 3. Technical and scientific description of the RI
 - Scattered throughout several deliverables

Gap analysis: availability of documents needed to set up MIRRI-ERIC

- 4. Declaration of the host state recognising ERIC an international body and international organisation within the meaning of the directives of VAT and excise duties
- 5. If members are associated countries, third countries or intergovernmental organisations: a declaration recognising the legal personality and capacity of the ERIC
 - Templates are available
 - To be completed and signed by associated countries, third countries and intergovernmental organisations that want to become member of MIRRI-ERIC
